1. Who we Are

We are Carcinotech Ltd, a company incorporated in Scotland with registered number SC604026 and having our trading office address as Roslin Innovation Centre, Easter Bush Campus, Midlothian, EH25 9RG.

We are a controller for the purposes of the General Data Protection Regulation (Regulation (EU) 2016/679) and related data protection legislation. We are registered with the Information Commissioner's Office (as the regulator of data protection and relevant supervisory authority in the UK) under registration reference ZA771024.

3. Privacy Information

We are committed to protecting your personal data and your privacy. This privacy notice aims to give you information on how we collect and process your personal data through your use of our website <https://www.carcinotech.com/> or any other website registered in our name ("Website"), including any personal data that you may provide through our Website, where we have a contract in place with you (please note that separate terms and conditions may also be applicable here) or otherwise provide services to you, and through other interactions we have with you or other communications with us.

It is important that you read this privacy notice when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your personal data.

It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.

This version of our privacy notice was last updated in December 2024.

4. To Whom does this Privacy Notice Apply?

This privacy notice applies to:

- all individuals who visit our Website;
- all individuals who are or were our "individual customers" where you are a sole trader, partner in a traditional or limited partnership or member of an unincorporated association;
- all individuals who are current or former employees, workers, directors, officers, job applicants or otherwise related personnel of our corporate customer (being a corporate entity such as a limited company or limited liability partnership) or individual customer ("customer-related individuals");
- all individuals who are our "business contacts" where you or your organization supply goods or services to us, provide professional services, have expressed an interest in us or have any other business relationship with us (including where your organization is a public authority, an industry body or regulatory authority or similar); or
- all individuals who are our "shareholders" and/or "investors".

This privacy notice does not apply to employees, workers or other staff of Carcinotech Ltd.

5. Information About our Website

Our Website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and we are not responsible for their privacy statements. When you leave our Website, we encourage you to read the privacy notice of every website you visit.

6. Cookies

Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of the Website may become inaccessible or not function properly.

7. Children

Our Website and any services we offer are not intended for children and we do not knowingly collect any personal data relating to children.

8. About the Personal Data That we Collect and Process

"Personal data", or personal information, means any information about an individual from which that person can be identified. It does not include data where an individual's identity has been removed (**"anonymous data"**).

We do not collect or process special categories of personal data or any data regarding criminal convictions or offenses.

The table set out in SCHEDULE 1 summarizes the personal data we collect and process, how we use it ("our processing purposes") and why we use it (**"the lawful bases of processing"**).

We may also collect, use and share **"Aggregated Data"** such as statistical or demographic data for any purpose. Aggregated Data may be derived from your personal data but is not considered personal data in law as this data does not directly or indirectly reveal your identity. For example, we may aggregate data to calculate the percentage of individuals accessing a specific feature of our Website. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy notice.

9. How is your Personal Data Obtained?

We use different methods to collect personal data from and about you including through:

- **Direct interactions.** You may give us your identity, contact, financial, transactional or similar personal data when you correspond with us by post, phone, e-mail or otherwise, by interacting directly with us through our Website or otherwise.
- **Direct interactions with business contacts, individual customers and customer-related individuals.** You may give us your identity, contact, financial, transactional and other business-related personal data when you correspond with us, including when:
 - you or your organization negotiate and/or enter into a contract with us; or
 - you or your organization provide services or products to us or your or your organization receives services or products from us; or
 - you provide us with your business card.
- **Direct interactions with our investors and/or shareholders.** You may give us your identity, contact and other business-related personal data in the process of investing in Carcinotech Ltd or where you communicate with us as a shareholder in Carcinotech Ltd.

- **Automated technologies or interactions.** As you interact with our Website, we may automatically collect technical data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, and other similar technologies.
- **Third parties or publicly available sources.** We may receive personal data about you from various third parties and public sources as set out below:
 - where you are a business contact, your organization or business may provide us with your identity and contact data.
 - where you are a customer-related individual, your organization or business may provide us with your identity and contact data.
 - we may obtain identity and contact data from publicly available sources such as social media (such as LinkedIn or Twitter), Companies House or other organizations' websites.
 - we may obtain contact, financial and transaction data from providers of payment and credit card services.
 - we may obtain technical data (relating to the use of our Website) from analytics providers or search information providers.
 - where you are a member of an investment syndicate investing in Carcinotech Ltd the syndicate may provide your personal data to us as part of the transaction.
 - Our carefully selected partners and service providers who process personal information about you on our behalf.

10. Failure to Provide Personal Data

Where we need to collect personal data by law or under the terms of a contract, we have with you (or are trying to enter into with you) and you fail to provide that data when requested, we may not be able to perform the contract. In this case, we may have to cancel a contract (but we will notify you if this is the case at the time).

11. Marketing

If you represent another business, we may provide you with direct marketing communications where we feel that this may be relevant to your business (provided that you have not opted out of such communications). When we use your personal data for such purposes, we do so on the basis that it is in our legitimate interests to pursue direct marketing, provided that it constitutes fair processing of your personal data to do so.

We aim to give you choices around personal data uses (particularly around marketing and advertising). Accordingly, you can also opt-out or unsubscribe from all or some of these marketing communications at any time by contacting us at info@carcinotech.co.uk

Where you opt out of receiving these marketing communications, this opt-out will not apply to personal data provided to us for any other purpose.

12. With Whom do we Share Your Personal Data

There may be circumstances in which we may also need to share your personal data with certain third parties (strictly on a confidential, business need-to-know basis). The third parties to which we may transfer your personal data include:

- Your business or organization, for the purpose of providing our services or products to your business or organization or receiving products or services from your business or organization.
- Our investors and/or shareholders.
- Service providers acting as processors who provide services to us, including digital marketing providers, systems administration services and IT provider.
- Professional advisers including lawyers, bankers, accountants, auditors and insurers who provide consultancy, banking, legal, insurance and accounting services.
- Any relevant accreditation body or trade association.
- Any relevant regulatory authority or law enforcement agency, including the relevant supervisory body for privacy matters, HM Revenue & Customs (or equivalent tax authority in your jurisdiction), courts or tribunals who require reporting of processing activities in certain circumstances.
- Third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this privacy notice.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

Any sharing of your personal data will only take place either where we are legally obliged to do so, where it is necessary for the performance of a contract with you or where it is in our legitimate interests to do so, including as follows:

- to maintain network and information security;
- to provide services or products to our corporate customers;
- to develop and improve our services or products in order to remain competitive;
- to establish, protect and defend our legal rights;
- to pursue our commercial objectives where this does not override your rights and freedoms as a data subject.

13. Sale of Personal Data

We do not knowingly sell any personal data (including personal data of any North American customers) to any third party at any time. In this paragraph, “sold” includes any selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, personal data to another business or third party for monetary or valuable consideration.

If we do sell your personal data, we will notify you where required under applicable data protection law, and if you submit to us an appropriate request using the contact information above, we will disclose to you a list containing the categories of personal data we have sold (as we are required under certain data protection laws).

14. International Transfers

As we operate on an international basis, and provide an online service through our website, we may (a) need to transfer your personal data outside of the UK or European Economic Area (EEA) or (b) receive your data from outside the UK or EEA. We generally host and process all personal data within the UK or the EEA. However, whenever we are required to transfer your personal data internationally (for example where a third-party supplier is located outside of the UK or EEA), we ensure a similar degree of protection is afforded to it by ensuring that appropriate safeguards are implemented, including any of the following:

- We will only transfer your personal data to countries that have been deemed to provide an adequate level of protection for personal data by the ICO or other appropriate supervisory body.
- We may use specific contracts approved for use in international transfers and give personal data appropriate levels of protection (like the International Data Transfer Agreement approved by the ICO, or Standard Contractual Clauses approved by the European Commission).
- We may rely on another ground or exemption to allow us to transfer the personal data internationally. For example, where you are based out with the UK and have engaged us for services, we will rely on the transfer being necessary for the purposes of performing a contract between us and you, or your explicit consent to the transfer of your personal data outside of the UK or the EEA.

You can contact us if you want any further information on any international transfers of your personal data.

Please note that when you provide us with personal data from outside of the UK, this is not considered an international transfer by us. Once personal data is received by us, the information above will apply to any onward transfer by us of personal data.

15. Automated Decision Making and Profiling

We do not use automated decision-making (including profiling) to make any decisions which would produce a legal effect or similarly significantly affect a data subject.

16. How Long do we Retain your Personal Data?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

Personal data relating to Website users and business contacts will generally not be retained for longer than 12 months unless such data is relevant to ongoing services. Personal data relating to individual customers and customer-related individuals will generally not be retained for longer than 7 years after conclusion of the relevant services unless such data is relevant to any legal, accounting or reporting requirements. 17. Data Security

We know that it is incredibly important to protect and manage personal data appropriately, but unfortunately the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted online or through our website.

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorized way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

18. Your Rights

The legal rights you have will depend on the country in which you access our website and receive the services. The rights detailed below apply in relation to the UK. Where you are based out with the UK, you may have different or additional rights in respect of your personal data. If this is the case, please contact us and we will confirm any additional rights which may apply.

Additional Rights

How to exercise

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

Where any of the rights exercised require us to provide you with information, we will do this by your preferred delivery mechanism. If the information is provided to you electronically, we will provide you the information in a portable format and, to the extent technically feasible, in a machine readable, readily useable format that allows you to freely transmit this information without hindrance.

No fee usually required

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we may refuse to comply with your request in these circumstances.

Time limit to respond

We try to respond to all legitimate requests within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

SCHEDULE 1

Personal data will be processed by us where you consent to the processing or where that processing is necessary for 1) the performance of a contract with you; or 2) compliance with a legal obligation to which we are subject; or 3) the purposes of our legitimate interests (or those of a third party).

Legitimate interests mean the interest of our business in conducting and managing our business to enable us to give you the best service/product and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). You can obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities by contacting us.

We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.
